## Description of the graduate's profile

### General characteristics

The graduate in the study programme:

- ☐ has a broad knowledge of the theory and application of law in the field of the protection of persons and property.

- ☐ acquires theoretical knowledge in the field of the legal and security protection of persons and property, developed his/her intellectual abilities, practical skills and personality traits which make it possible for him/her to individually prepare and implement complex legal, organizational and professional measures for creating adequate systems for the efficient provision of the protection of persons and property.
- ☐ is able to analyse the security environment, perform security analyses, suggest and reach suitable solutions concerning the protection of persons and property also in emergency and crisis situations.
- ☐ acquires knowledge which enables him/her to coach middle and senior management teams, organize cooperation and coordinate their activities with other subjects.
- ☐ can use his/her acquired knowledge while ensuring international cooperation and fulfilling tasks in accordance with the requirements of supranational and international security bodies and organizations.

The graduate has such theoretical knowledge that he/she is capable of continuing his/her university studies for a PhD degree.

#### Theoretical knowledge

The graduate in the study programme:

- ☐ acquires complex knowledge in the field of the application of legal regulations while managing the process of detecting, registering and dealing with prohibited activities in the area of the protection of persons and property,
- ☐ can independently, creatively and complexly deal with phenomena and processes in the area of the security and legal protection of persons and property on the basis of his/her scientific theoretical knowledge,
- ☐ can scientifically analyse problems occurring in the area of the protection of persons and property as well as produce and implement conceptual purposes, suggestions and projects of the activities of organization units and divisions within security services,
- ☐ acquires knowledge necessary for issuing internal regulations designed to specify the activities of individual organization units within the structure of security services which provide the protection of persons and property,
- ☐ can scientifically analyse the state, structure and dynamism of crime, understand its causes and conditions, the personality of the offender and the victim of crime as well as impose efficient measures for crime prevention,
- ☐ acquires extensive knowledge of the effective management of the activities performed by individuals, professional teams and controlled systems while applying modern management methods in the structure of security services.

#### Practical skills and abilities

The graduate in the study programme acquires the ability:

- ☐ to specify, suggest and implement complex solutions concerning the security and legal protection of persons and property,
- ☐ to understand and analyse the phenomena and processes which have an impact on the activity of security systems and individual security services,
- ☐ to identify, analyse and assess security risks and threats connected with the protection of persons and property,
- ☐ to direct his/her attention to central tasks and problems which may arise during practising his/her profession and to the process of handling crisis situations,
- ☐ to anticipate events, control his/her own behaviour and activities also in stressful situations and manage the changes in security systems,
- ☐ to systemically deal with information, gather, handle and analyse data, using modern information technologies.

#### Additional knowledge, abilities and skills

The graduate in the study programme can:

- ☐ work individually in professional, specialized working teams within the middle and senior management and, after gaining some professional experience, coach them effectively, ☐ organize the cooperation with the bodies of state administration, local government, representatives of civil associations and natural persons in order to effectively provide legal and security protection of persons and property,

- present legal and organizational issues concerning security protection of persons and property to particular categories of individuals,
- undertake his/her professional activity in compliance with legal and ethical norms and ensure that they are followed also in his/her working environment,
- detect new trends in the field of the protection of persons and property and apply them creatively in practice as well as extend and broaden his/her knowledge in the field of his/her study and stimulate his/her further professional development

### Prospects of the graduate

Graduates can hold positions of: members of the middle and senior management staff in state as well as non-state security services and organizations which perform specialized security-related activities connected with the protection of persons and property; independent employees – specialists in the complex evaluation of systems of the protection of persons and property within the police and security services.
