The aim of the conference is to focus on a highly actual and socially important topic that resonates within European space, and that is security. In this context, focus on security actors, thus highlighting the exceptional position of the police, police officer, members of Police Force as a guarantor of security. To deal with the areas of Fundamental Human Rights and Freedoms in the presented context, to point out the fundamental rights, powers and duties of a police officer (constitutional, criminal and administrative aspects), that must be observed in the implementation of his activities. At the same time, it should be devoted to the platform of security at both national and international level.

New findings and results from the scientific research task No. 204/2014 APZ will be presented.

The purpose of the International Scientific Conference is to highlight the role of the police (with emphasis on the status of the Police Force) as a guarantor of security, while stressing that both national and international security are an essential element of the functioning of the state in international relations.

7. National Minorities and Police Activities.
8. Police and security of participants in public sports events.
9. Self-government and population security.
10. The European Union and its internal security.
11. Police and information security.
