Security and Legal Protection of Persons and Property - civilian applicants

**Deadline for applications:** 31 January 2017

**Entrance exam:**

- physical fitness test and psychological examination after 27 March 2017
- general knowledge test after 12 June 2017

Security and Legal Services in Public Administration

**Deadline for applications:** 31 March 2017

**Entrance exam:** general knowledge test after 12 June 2017

**DOCUMENTS TO BE SUBMITTED TOGETHER WITH THE APPLICATION FOR  
THE BACHELOR'S DEGREE STUDY**

- a brief CV,
- a public administration employee shall submit a confirmation of the employment by their employer,
- civilian applicants for the study programme Security and Legal Protection of Persons and Property shall submit a medical report on the fitness for university study,
- a counterfoil confirming the payment of the fee for the expenses connected with the admission procedure.

**MASTER'S DEGREE STUDY (MGR)**

**Full-time study - 2 years / Part-time study - 3 years**

**Deadline for applications:** 10 July 2017

**Entrance exam:** July 2017

**DOCUMENTS TO BE SUBMITTED TOGETHER WITH THE APPLICATION FOR  
THE MASTER'S DEGREE STUDY**

- a brief CV,
- a verified copy of documents on completion of the 1st university degree in the study programme Security and Legal Protection of Persons and Property, in the study programme Security Services and in the study programme Security and Legal Services in Public Administration,
- a counterfoil confirming the payment of the admission procedure fee.

**Additional Information for Applicants**

The applicants use the Application Forms for university study in the Slovak Republic with appropriate attachments and they submit the application in electronic form as well.

The applicant is obliged, without delay, to provide information on any changes which have arisen since the submission of the application for the study before the admission procedure, and before the enrolment for the study. A civilian applicant proves their civilian integrity by the extract from the criminal record not more than 3 months old. In case there is a record on commission of an intentional crime, the applicant will not be enrolled for the study.

## **Tuition Fee**

When a student exceeds the standard period of study within the study programme, the yearly tuition fee for the academic year 2017/2018 in the study programmes Security and Legal Protection of Persons and Security and Legal Services in Public Administration is 500 €.

The yearly tuition fee for the part-time study for the academic year 2017/2018 in study programmes Security and Legal Protection of Persons and Security and Legal Services in Public Administration is as follows:

- Bachelor's degree study = 450 €,
- Master's degree study = 500 €.
